## **BANGALORE WINTER MEETING 2013-14** **(Under B.T.C. Rules of racing)**

### **NOTICE**

#### **REG: ALLOTMENT OF STABLES TO OUTSTATION HORSES ON A PERMANENT BASIS AT BANGALORE FOR PARTICIPATING IN BANGALORE RACES**

Trainers and owners are hereby informed that Bangalore Turf Club Ltd. will permit the following category of horses coming from any racing centre in India for allotment of stables on a permanent basis at Bangalore to participate in Bangalore races:

- (1) Horses aged 3 years.
- (2) Horses aged 4 to 6 years rated 50 and above under B.T.C. Rules of Racing.

However, the allotment of stables to these horses, are subject to the following conditions:

- (a) Application for allotment of stables should be made on or before 31st December, 2013.
- (b) A maximum of five horses only will be allowed per trainer/owner.
- (c) 3-year-old horses will be allotted a rating of not less than 28 in respect of colts and geldings and 25 in respect of fillies under B.T.C. Rules.
- (d) A maximum of 50 eligible horses will be considered for allotment of stables under the above scheme on a first-come first-serve basis subject to availability of stables.
- (e) These horses should be under the charge of "A" licensed trainers based in Bangalore provided the upper limit of horses per trainer as per the existing norms is not exceeded.
- (f) These horses will be treated as local horses except that the Owner/Trainer will not be extended any subsidy in respect of such horses for the first one year.
- (g) These horses will be treated as full fledged local horses after one year from the date of arrival of such horses in B.T.C. Premises and will be extended all the benefits given to local horses thereafter.
- (h) A service charge of Rs. 1,00,000/- per horse will be levied on the owner/trainer in case such horse leaves B.T.C premises before completing one full year or even if the horse fails to participate at least four times exclusively at Bangalore within one year. The above service charge will not be condoned under any circumstance.
- (i) Allotment of stables will be at the entire discretion of the management which will be final and binding.

- (j) All horses arriving at the premises of Bangalore Turf Club Ltd., should possess the following documents without which they will be strictly prohibited from entering the B.T.C. premises:
- (1) A valid Coggins Test Certificate negative for E.I.A.
  - (2) A health Certificate from the Senior Veterinary Officer of the respective club stating that the horse does not show any clinical signs of E.I.A., Glanders, AHS strangles or Equine Influenza at the time of its departure.
  - (3) An endorsement in the passport to the effect that they have been administered with approved vaccination against Equine Influenza. The details of the vaccination such as Date and Name of the Vaccine, Batch No. and Expiry date (Vignette) should be endorsed in the passport and must be duly signed by the Senior Veterinary Officer of the respective club.
- (k) Horses on arrival should be produced before the club's veterinary officer and a certificate of soundness obtained without which horses will not be allowed to occupy the stables.
- (l) Permission granted for permanent allotment of stables will automatically stand cancelled in case of horses who do not occupy stables within 15 days of grant of such permission.
