ORDER OF THE STEWARDS

8th Race: 17. The Sarb-Kla Plate - Div.I - (About) 1400 Metres.
Horses rated 20 to 45.

Just passing the final 100 Metres Jockey Ahsan Qureshi, the rider of ABSOLUTE RED, placed First by the Judge came in sharply causing severe interference to ANCIENT TITLE (P. Kiran Rai) racing along the rails which struck the former and fell down dislodging its rider, broke the false rails and was reported to have sustained bleeding cut injury at the base of the tail (coccygeal). As a consequence ARZIKI (P. Trevor) moving on the far side shied away from the falling horse and the rider and took out MANTA RAY (P.S. Chouhan) on its outside whereby both the horses had to be checked by their respective riders and moved out. ATTRACTIVE BAY (Arshad Alam) which was moving from behind ANCIENT TITLE (P. Kiran Rai) shied away from the prostrated horse and the rider, and violently moved out whereby the rider got totally unbalanced and was dislodged from his mount. CARDIGAN BAY (K. Raja Rao) moving from behind to avoid colliding with the riderless horse viz. ATTRACTIVE BAY in an evasive action moved out. CZAR RULE (M.A. Roushan) moving behind CARDIGAN BAY (K. Raja Rao) had to be shifted out to avoid running over the prostrated rider viz. Jockey Arshad Alam. LOVE IS LIFE (M. Noornabi), BERING SEA (B. Harish), HIMAVARI (S. Mallikarjun) and SMOKEHEAD (C. Harish) all moving simultaneously from behind had to be checked and shifted out as a chain reaction and BERING SEA (B. Harish) ultimately landed on the outer sand track. Thus in effect in a field of 12 horses except ABSOLUTE RED (Ahsan Qureshi) and STIMULATE (S John), the other runners suffered interferences of varied degree whereby the riders of these horses could not ride out their respective mounts and further two horses finished riderless. In view of the above, at the behest of the Stipendiary Stewards, the Stewards ordered and held an enquiry immediately after the race into the running of the above race. After repeatedly viewing the CCTV replay of the race, acting on their own observation of the running of the race, after detailed deliberations and by virtue of powers conferred under Rule No.31(a) of the BTC Rules of Racing, decided to declare the race Null and Void.
