## BANGALORE SUMMER MEETING 2014 NOTICE

1. As regards the visiting Horses, the following categories of horses alone are eligible for allotment of stables in order of priority subject to the availability of stables:-

(a) All 3 and 4 years old that are entered for Bangalore Summer Classic/s

2014 and not struck out till the date of stable allotment.

(b) 3 and 4 years old that are entered for at least FIVE Sweepstakes races to be run during Bangalore Summer Meeting 2014.

(c) Horses aged 3 to 8 years rated above 65.

Notwithstanding the above, horses which have not placed first, second, third or fourth in their last ten starts will not be allotted

- 2. Visiting Horses will not be allowed to participate in races earmarked for horses rated 00 to 25.
- 3. Application for allotment of stables shall be accompanied by a deposit towards service charge @ Rs.20,000/- per stable. The deposit shall be paid by a crossed Demand Draft in favour of Bangalore Turf Club Ltd., payable at Bangalore. Application not accompanied by the requisite Demand Draft will not be accepted.
- 4. All horses arriving at the premises of Bangalore Turf Club Ltd., should possess the following documents without which they will be strictly prohibited from entering the B.T.C. premises:-
- (i) A valid Coggins Test Certificate negative for E.I.A.
- (ii) A health Certificate from the Senior Veterinary Officer of the respective club stating that the horse does not show any clinical signs of E.I.A., Glanders, AHS strangles or Equine Influenza at the time of its departure.
- (iii) An endorsement in the passport to the effect that they have been administered with approved vaccination against Equine Influenza. The details of the vaccination such as Date and Name of the Vaccine, Batch No. and Expiry date (Vignette) should be endorsed in the passport and must be duly signed by the Senior Veterinary Officer of the respective club.

Application for allotment of stables should be submitted on or before 30th April, 2014. Date from which the horses would be permitted to arrive at B.T.C. premises will be notified soon. Till such time, no horse will be permitted to enter the B.T.C. premises.

Faxrainers and owners are Aereby 4746000 that Bangalore Turf Club Ltd. will permit the following category of horses coming from any racing centre in India for allotment of stables on a permanent basis at Bangalore to participate in Bangalore

(ii) Horses aged 4 to 6 years rated 50 and above under B.T.C. Rules of Racing.

However, the allotment of stables to these horses are subject to the following conditions:

- a) Horses which have not placed first, second, third or fourth in their last ten starts will not be allotted stables.
- b) A maximum of five horses only will be allowed per trainer/owner.
- c) A maximum of 50 eligible horses will be considered for allotment of stables under the above scheme on a firstcome first-serve basis subject to availability of stables.
- d) These horses should be under the charge of "A" licensed trainers based in Bangalore.
- e) These horses will be permitted in excess of the upper limit of 40 local horses per trainer.
- f) These horses will not be permitted to participate at any other centre without running at least once at Bangalore.
- g) These horses will be treated as local horses except that the Owner/Trainer will not be extended any subsidy in respect of such horses for the first one year.
- h) These horses will be treated as full fledged local horses from 15<sup>th</sup> May, 2015 and will be extended all the benefits given to local horses thereafter.
- A service charge of Rs. 1,00,000/- per horse will be levied on the owner/trainer in case such horse leaves B.T.C premises before 15<sup>th</sup> May, 2015 or even if the horse fails to participate at least four times exclusively at Bangalore within one year. The above service charge will not be condoned under any circumstance.
- j) Allotment of stables will be at the entire discretion of the management which will be final and binding.
- k) All horses arriving at the premises of Bangalore Turf Club Ltd., should possess the following documents without which they will be strictly prohibited from entering the B.T.C. premises:-
- A valid Coggins Test Certificate negative for E.I.A.
- A health Certificate from the Senior Veterinary Officer of the respective club stating that the horse does not show any clinical signs of E.I.A., Glanders, AHS strangles or Equine Influenza at the time of its departure.
- An endorsement in the passport to the effect that they have been administered with approved vaccination (iii) against Equine Influenza. The details of the vaccination such as Date and Name of the Vaccine, Batch No. and Expiry date (Vignette) should be endorsed in the passport and must be duly signed by the Senior Veterinary Officer of the respective club.
- I) Horses on arrival should be produced before the club's veterinary officer and a certificate of soundness obtained without which horses will not be allowed to occupy the stables.
- m) Permission granted for permanent allotment of stables will automatically stand cancelled in case of horses who do not occupy stables within 15 days of grant of such permission.
- n) In case a horse fails to participate in at least two races during BSM 2014, service charges as detailed below will be debited to the account of the Owner concerned:

If the horse does not race at all

Rs. 25,000/-

If the horse runs once

Rs. 12,500/-
