 6. The paper should be wound on spool of inner dia 1/2" with the Thermal Coating facing outside
 7. Suitable colour marking for **two meter** on the inside edge of the paper roll to indicate end of paper on the roll. In the event of any lapses a penalty will be imposed at the discretion of the Secretary. Further there should not be any joint in the roll.
 8. The paper rolls should be packed in good quality black polythene bag (48 Microns) and should be packed in good quality cardboard box of 30 rolls in each with polythene sealed.
