STEWARDS INSTRUCTIONS FOR THE GRANT OF JOCKEYS LICENCE UNDER THE RULES OF RACING OF BANGALORE TURF CLUB LIMITED

- 1. Jockeys are notified that application vide email will be entertained. An application for a Licence must be submitted in the prescribed form and must state approximate lowest riding weight and be accompanied with licence fee and clearance and must also be accompanied with the old or expired Licence if held.
- 2. For condition of Licences the Stewards of the Club draw the attention of all persons seeking Jockey's Licences to the Section of Rules covering Jockeys and Riders Licences, etc., (Rules of Racing)
- 3. Jockeys whose Licences have not been issued are reminded that Licence is necessary before they can ride work or ride in Races.
- 4. An application for a Licence under the Rules of Racing of Bangalore Turf Club Ltd., form a Jockey who holds or has held a Licence under the Rules of a recognized Club in any country outside India will be considered and the Licence may be granted if the applicant produces a Licence and clearance from the recognized Club/s in the country in which he has last ridden.
- 5. (a) An application for a Licence under the Rules of Racing of Bangalore Turf Club Ltd., from a Jockey who holds or has held a Licence under the Royal Calcutta Turf Club, Royal Western India Turf Club Ltd., Madras Race Club, Hyderabad Race Club or Mysore Race Club Ltd., Rules will be considered and the Licence may be granted if the applicant produces a clearance from the respective Clubs.
 - (b) In case a Jockey applies for a 'B' Licence at this centre, he should have ridden at least 20 Rides and should have ridden Three horses which have placed First, Second or Third.
 - (c) Renewal of Licence is subject to satisfaction of Norms.
- 6. If a person applying has never had a Licence, the application must be accompanied along with particulars of past employment and the name of the person (if any) who intends to employ him.
- 7. No Jockey shall ride at any Race Meeting in India not sanctioned by or held under the Rules of this Club, The Royal Calcutta Turf Club, Royal Western India Turf Club Ltd, Madras Race Club, Hyderabad Race Club or Mysore Race Club Ltd.,
- 8. A Jockey whose Licence has been withdrawn is a disqualified person unless the Stewards of the Club in their discretion shall otherwise determine.
- 9. Jockeys shall not be Owners, or part-owners or in any way interested in ownership of any race horse.
- 10. In so far as it relates to their riding engagement, Jockeys shall not receive any presents from persons other than the Owners or their Authorised Agents of the horses they ride. The Jockeys shall also forthwith declare any such above presents they receive from Owners or their Authorised Agents of the horses they ride.
- 11. Jockeys shall not bet, or engage directly between the Jockeys directly or indirectly in any betting transaction and shall not be connected with any Bookmaker (both legal and illegal) involving betting transaction.
- 12. The retainer or any special agreement between the Jockey and his employer should be registered with the Club compulsorily.
- 13. At the time of applying for a Licence, the Jockey should produce a Fitness Certificate from the panel of Medical Officers appointed by Bangalore Turf Club Ltd.,
- 14. Jockeys are notified that riotous behavior, intemperance or any other conduct which is likely to disrupt the normal conduct of the races will be taken cognizance of by the Stewards.
- 15. The validity of the Licence is from the date of sanctioning of Lience till 31st of March of the succeeding year. However, the Stewards have the power to suspend, revoke or cancel the Licence of a Jockey at any time for a breach or violation of the Rules of Racing.
- 16. All applications for Jockeys's Licence should be accompanied by a Fee of Rs.250/- plus Service Tax which in the event of the Licence being granted will be credited to the Club's Benevolent Fund.
- 17. (a) The grant or refusal of the Licence shall be at the absolute discretion of the Stewards.
 - (b) Where an application for grant of a Licence is refused, the applicant shall be informed of the reasons of refusal in writing within seven days from the date of receipt of application.
 - (c) The applicant may within a period of Seven days from the date of receipt of the order of refusal in writing apply for reconsideration to the Stewards of the Club.
 - (d) The Stewards of the Club shall within a period of Ten days from the date of application for reconsideration give an opportunity of hearing in person to the applicant and thereafter an order with reason shall be passed by the Stewards which shall be communicated in writing to the applicant.
