**Subject: Order of The Board of Appeal.**

Ref: against the decision of the Stewards at their meeting held on 18<sup>th</sup> June 2018 (in continuation of Stewards meeting held on 21<sup>st</sup> May 2018, 29<sup>th</sup> May 2018, 13<sup>th</sup> June 2018) pertaining to withdrawal of existing permission of Private Veterinary Practitioner Dr. C Satish, and not to grant further permission, as a Private Veterinary Practitioner in future and treating him as a disqualified person with effect from 3<sup>rd</sup> July 2018 to 2<sup>nd</sup> July 2019 (both days inclusive) for indulging in improper practice of administering "PREMARIN" containing "ESTROGEN" which is a sex hormone and is a banned/prohibited substance (under proscribed list) on b.rig RAFA without notifying and taking prior approval from the Chief Veterinary Officer, thereby contravening Rule No 202(i) and 202(x)(a)(i) of the BTC Rules of Racing read with Calendar Notification under the heading "ANABOLIC STEROIDS AND SEX HORMONES".

The Board of Appeal at its meeting held on Wednesday 11<sup>th</sup> July, 2018, considered your appeal dated 22<sup>nd</sup> June 2018. After consideration of all the information, explanation, documents and the submission during the hearing of the Appeal, the Board of Appeal unanimously decided as follows:



**Ref: Appeal is against order of the Stewards at their meeting held on 6<sup>th</sup> June 2018, in contravention of Rule No 159(b) of the BTC Rules of Racing pertaining to mount AGNETA in Race no 28, The Brig. R. C. R. Hill Memorial Trophy- (About) 1400 Meters for horses rated 30 to 50, run on 27<sup>th</sup> May 2018.**

The Board of Appeal at its meeting held on TUESDAY 26TH JUNE, 2018, considered your appeal. Following is the decision:

After consideration of all the above information, explanation, documents and the submission during the hearing of the Appeal, the Board of Appeal unanimously decided as follows:

- a) To **consider** the plea appeal filed by Mr. S.K. Paswan. (Based on his economic condition and livelihood being prime concern to board).
- b) To **modify** the charging rule from 159(b) to rule 161(ii).
- c) To **remove** disqualification of Jockey Mr. S.K. Paswan.
- d) To **modify** the punishment by reducing License withdrawal of Jockey Mr. S.K. Paswan from 10 months to 6 months.
- e) To **Allow/Permit** Jockey Mr. S.K. Paswan to ride work.
- f) To **Caution** Jockey Mr. S.K. Paswan to be very careful while in future, not to repeat any mistakes in future.
- g) To **forfeit** Rs. 5,000/- from Jockey S. K. Paswan towards the Appeal fee.

## ORDER OF THE BOARD OF APPEAL


1. The Board of Appeal at its meeting held on Thursday, 10<sup>th</sup> May, 2018, considered and perused the following:

Ref: Appeal against the decision of the Stewards at their meeting held on 18<sup>th</sup> June 2018 (in continuation of Stewards meeting held on 21<sup>st</sup> May 2018, 29<sup>th</sup> May 2018, 13<sup>th</sup> June 2018) pertaining to withdrawal of license of Trainer Mr. S. Dominic and treating him as a disqualified person from 3<sup>rd</sup> July 2018 to 30<sup>th</sup> April 2019 (both days inclusive) for the negligence in discharge of his duties as a Licensed Trainer and for the improper practice by not ascertaining the contents of "PREMARIN" containing "ESTROGEN" which is a sex hormone and is a banned/prohibited substance (under proscribed list) on b.rig RAFA thereby contravening Rule No 114(b)(i) read with 202(i) of the BTC Rules of Racing.

The Board of Appeal at its meeting held on Wednesday 11<sup>th</sup> July, 2018, considered your appeal dated 20<sup>th</sup> June 2018. After consideration of all the information, explanation, documents and the submission during the hearing of the Appeal, the Board of Appeal unanimously decided as follows:

- To **partly set aside** the punishment awarded by the Stewards by withdrawing your license and treating you as a disqualified person for a period of Four months with effect from **16<sup>th</sup> July 2018 to 15<sup>th</sup> November 2018 (both days inclusive)**.
- To **forfeit** Rs. 5,000/- towards the Appeal fee.
