Reg: Allotment of Stables for Two year old horses for the year 2021 (Foaled in 2019)

- An application form to be submitted duly filled in and signed by the trainer enlisting the details of the 2 year old/s.
- 2. Sale form /Lease forms (with consideration amount) for the respective two-year-olds to be submitted in BTC Dispatch Section under acknowledgement along with the application form and
 - a) <u>latest Income Tax Returns of the owner</u> disclosing income / expenditure with respect to maintenance of Race horses
 - b) In the absence of Income Tax returns of the Owner the following document/s shall be submitted:
 - i) 26 A Certificate and / or
 - ii) Acknowledgement coupled with a Chartered Accountant statement that the Racing Account has been filed and , a clause supporting the certificate that if the details submitted is false, the owner is liable for the same , and will have to produce the relevant documents with immediate effect.
- 3. The Sale/Lease documents should be clear in all respects for consideration of stable allotment. The validity of the Lease shall be for a minimum period up to 31st August, 2021. Further, registration of two-year-olds shall not be permitted after 31st August, 2022.
- 4. Horses should not be loaded until permission has been obtained or intimated in writing by the office to the respective trainers. Should the horse arrive at BTC without the necessary permission, the horse shall not be allowed under any circumstances whatsoever into the Racecourse and the Club will not be responsible for any consequences.
- 5. An approval from the office for stable allotment will be intimated to the respective trainers at the earliest after receipt of applications by the Club and subject to valid documentation.
- 6. Any change in Trainer/Owner after registration shall be effected only after 31st December 2021 except:-
 - (a) Where the owner is transferring all his horses, and in such a case, the transfer of two-year-olds shall be permitted only if it is within the original allotted quota of the Trainer receiving the horse/s and also subject to Stewards decision which shall be final and binding, where the change of owner is within the same Trainer.
- 7. Registration of horses will be limited to the quota allotted to each trainer as per enclosure (on a priority of registration) upto a maximum of **225 two-year-olds**.
- 8. Registration of name will be effected only after the registration of ownership is completed and the last date for the registration of names (2019 foals) will be 31st January, 2022.
- 9. Change of name will be permitted only if the horse has run at least once under BTC Rules of Racing.
- 10. In case any Trainer does not utilize the Quota which was originally allotted to him, the same shall be intimated to the Club at the earliest and the same shall lapse thereafter and may be re-allotted at the discretion of the Club.
- 11. Two-year-old horses under the charge of a Trainer shall be stabled only in the respective Trainer's yard and not in any other Trainer's yard, any such violation shall be viewed very seriously by the Stewards of BTC and in such cases, the Trainer's License ipso facto shall be withdrawn by the Stewards.
- 12. Replacement of two-year-olds will be permitted only in case of mortality or under Veterinary grounds, no sponsorship quota shall be permitted, Stable allotment will be at the sole discretion of the Stewards and shall be final and binding.
- 13. The last date for furnishing the details of two-yr-olds which the trainer intend to bring into BTC premises in accordance to the quota allotted to them should be submitted to the office on or before 30th April, 2021.
- 14. An advance amount of Rs.10,000/- towards basic maintenance cost per two year old has to be paid prior to the <u>Sale Form</u> being lodged at office of B.T.C. and shall be adjusted against the dues from the concerned Owner or returned in case of an owner having credit balance in his/her account after a period of twelve months from the date on which the sale form is accepted.
- 15. An advance amount of Rs.20,000/- towards basic maintenance cost per two year old has to be paid prior to the <u>Lease Form</u> being lodged at office of B.T.C. and shall be adjusted against the dues from the concerned Owner or returned in case of an owner having credit balance in his/her account after a period of twelve months from the date on which the lease form is accepted.
- 16. Two year old (foaled in 2019) will be allowed into premises of Bangalore Turf Club Limited w.e.f **25th March**, **2021** and they have to leave the B.T.C premises once they turn 8 yr olds.
- 17. Trainers and Owners are hereby notified that no Sale/Lease form will be registered if the owner/trainers are in **Pre-Ban/ Ban/ Under Auction** at the time of registration.
