NOTICE

INWARD MOVEMENT OF 2-YEAR-OLDS OF 2021

The 2-year-olds registered at BTC shall be permitted to enter the BTC premises effective from **25th March 2021** subject to the following conditions:

1. Trainer has to submit the details of the 2-year-olds viz. expected date of arrival, details of the Horse Float, its origin etc., to Clerk of the Course to avail the Gate Pass during Club working days between 09:00 AM and 04: 00 PM and at least 2 -3 days in advance.
2. Trainer shall furnish the name and addresses of Horse Float personnel and status of their health condition (COVID-19).
3. Horse Float personnel shall carry their valid COVID-19 Negative Test Report which should not be older than 2 days from the date of Horse Float's departure.
4. The Horse Float shall be permitted only during Club's working days between 10:00 AM and 04:00 PM.
5. Per day maximum 20 horses permitted to enter.
6. Club's personnel shall disinfect the Horse Float on arrival if necessary.
7. The Horse Float shall be allowed only up to the ramp [loading and unloading area].
8. All the equipments used for the 2-year-olds during the transportation should be sent back through the Horse Float by replacing it with the fresh equipments.

9. It is the sole responsibility of the Trainer concerned and his personnel to unload and move the 2-year-old to the Stable near B Bund School for 24-hours quarantine.
10. It is the responsibility of the Trainer concerned and his personnel to make sure that no wastage / bedding materials etc., is left over in the unloading area. All left over waste should be taken back in the same Horse Float.
11. The Horse Float has to leave the BTC premises immediately after the 2-year-old is unloaded.
12. Trainer should ensure to submit the following documents:
 - a) Passport.
 - b) Valid EIA Negative Certificate (Validity 120 days)
 - c) Valid Glanders Negative Certificate (Validity 30 days)
 - d) 2-year-olds arriving from Stud Farms located in states where Glanders is either reported or Notified should possess a Certificate from Deputy Director/Joint Director of Animal Husbandry Department of that area stating that there is NO Glanders cases in that Stud Farm and also within the vicinity of 25 kms from the Stud Farms.
 - e) Health Certificate from the Veterinary Officer where the 2-year olds was last Stationed, stating that the 2-year olds neither suffered nor shown any clinical signs of infectious / contagious diseases like EIA, Glanders, EI, AHS, Dourine and strangles etc.
 - f) 2-Year-Olds should have been administered with a primary course of approved Calvenza /Fluvac Innovator EHV 4/1 Vaccine. The details of the Vaccination shall be endorsed in the Passport such as Date of Vaccination, Name of Vaccine, Date of Manufacture & Expiry, Batch Number duly signed by the Veterinarian.
