I, _____ hereby apply to the Stewards of the B.T.C Ltd., for a/an "A" / "B" Trainer's Licence (Applicant for a "B" licence should notify the Turf Authority under which he/she holds an "A" Trainer's licence _____) under the Rules of Racing of the Club for the year _____ to _____. This application is made on the following terms and conditions:

1. I have read all the relevant Rules of Racing, Medication Rules, Racing Calendar, the Rules of Track and Notices, Notifications, etc. which have been duly published and/or Notified by the B.T.C Ltd., in the Racing Calendar from time to time. I have understood all the implications of the said Rules and Notices and accept the legality.

2. I have familiarized myself with the procedures laid down from time to time by the Stewards of the Club for holding enquiries and/or otherwise dealing with matters arising out of and pertaining to racing. I accept the validity and reasonableness of the procedures and agree to be bound and observe all the Decisions and Orders of the Stewards of the Club as well as the Board of Appeal under the Articles of Association of the Club.

3. I undertake that the grant of such a Licence would be on an annual basis and I shall not claim or demand any right to renewal thereof. I further undertake that the issuance of this licence is liable to suspension and/or cancellation in the event of there being a breach on my part of the Rules and Notifications applicable to me.

4. I take the full responsibility of the Horses under my custody or which will subsequently come into and bound to be responsible to the Stewards of the Club for any irregularities or Breaches in the Rules, Regulations or Notices in connection with any of the Horses under my custody.

5. I undertake to look after and take care of the upkeep of the Horses under my custody and to diligently and faithfully discharge my obligations towards the Horses and the Owners thereof.

6. I undertake not to demand or claim any subsidy or allowance or any other financial support/facility in other manner from the Club.

7. I accept specifically the Right of the Stewards to limit the number of horses under my charge and also the Rights of the Stewards to allot at their sole discretion, such stables as may be available. I undertake not to claim any right in respect of any stable whatsoever or any particular Stable. I further undertake that the use of Stable allotted to me and the Bund School or Tracks for the purpose of training my horse is conditional upon my continuing to hold the said licence and I shall not claim any right in relation thereto of any kind whatsoever.

8. If I shall subsequently take a Horse other than those specified in application for a licence from any source, I undertake to notify the same with all necessary particulars, to the Club at once, stating the source from which I have taken over the Horse.

9. I undertake to intimate the Club at once the name and particulars of any Horse that shall leave my charge, giving the name of the person to whom I hand it over and the reason for doing so, by submitting the duly filled in necessary request form well in advance and upon approval by the club.

10. Any Official of the Club shall have the Right to enter my Stables or any place where my Horses are kept in my presence or of my Deputy or otherwise in the discharge of his Official Duties and/or for the purpose of satisfying himself that all the Rules, Notices and Conditions of this Licence are complied with.

11. I agree to be bound by the Medication Rules of the Club prevalent from time to time. In the event of any Samples of Sweat, Saliva and Urine taken being returned Positive or Atypical by the Lab's Analyst, the Owners of all horses in my charge will be duly informed of the fact by the Club and I agree to take full responsibility for the same and abide by any decision taken by the Stewards in this connection in accordance with the Medication Rules prevalent from time to time.

12. I accept that as a licensee of the Club I have an obligation towards smooth conduct and administration of Racing and I shall not take any action or step which will have the effect of in any way disrupting or adversely affecting the activity of Horse Racing at BTC.

13. I agree to pay the licence fee of Rs.3,090/- (which includes licence fee of Rs.500/-, Professional Tax of Rs.2500/-, CGST of Rs.45/-, SGST of Rs.45/-) or such other Fee as may be determined by the Stewards and accept that the said licence fee shall not be refundable in any circumstances should racing be disrupted or my licence be suspended or cancelled for any reason whatsoever.

14. I hereby authorize B.T.C Ltd., to debit from my Racing Account with the Club towards Licence Fee, Fines and Applicable Taxes, etc., or any other amount payable by me to the Club.

15. I confirm and state that as a Trainer, I am fully aware of my roles and the legal ramifications / obligations attached thereto as per the Gazette of India Extraordinary published by Authority under the Performing Animals [Registration] Rules, 2001 of the Ministry of Social Justice & Empowerment, New Delhi Notification dated 26/03/2001 – Part II – Section 3 – Sub Section (ii).

16. I confirm and state that I am fully aware of the provisions of the Prevention of Cruelty to Animals Act, 1960 and the Performing Animals (Registration) Rules, 2001 and acknowledge that I will be fully liable and responsible for any violation on my part in observing the provisions of the aforesaid Act and Rules including and not limited to ensuring the maintenance, welfare and wellbeing of the horse/s under my charge in my capacity as it's / their custodian.
