ORDER OF THE STEWARDS

BANGALORE SUMMER MEETING 2022 THIRTEENTH DAY, SATURDAY, 2nd JULY, 2022

Race: 75. The Supervite Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25.

The Stipendiary Stewards reported Jockey Arvind Kumar N to the Stewards for Contravention of Rule No. 159 (a) & (b) of the B.T.C. Rules of Racing on his mount BELDONA.

The Stewards held an enquiry on 21st September, 2022 and examined Spokesman Mr. R. Manjunath for Jockey Arvind Kumar N & Arvind Kumar N himself and Trainer Mr. Kishan Thomas.

The Stewards considered the following:

- ➤ The Compliant letter's dated 2/7/2022 lodged by Mr. Nanda Kumar (owner of the horse) and Trainer Mr. Kishan Thomas immediately after the said race;
- Charge sheet issued to Jockey Arvind Kumar N by the Stipendiary Stewards;
- ➤ The Submissions made by Spokesman Mr. R. Manjunath for Jockey Arvind Kumar N, and Trainer Mr. Kishan Thomas during the enquiry;
- > Stewards viewed various angles of the race with specific reference to the riding instructions not followed by Jockey Arvind Kumar N in the above race:
- ➤ The Stewards noted that Jockey Arvind Kumar N had not pleaded guilty of alleged breach of Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing as charged by the Stipendiary Stewards.

The Stewards also noted that Jockey Arvind Kumar N was already suspended by the Stewards of the club from **11-11-2022 to 17-12-2022 (Both days inclusive)** for Improper Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] on his mount THE ADVISER in Race No. 131 of the BSM 2022.

Thereafter using their wisdom and experience, they arrived at a unanimous decision that Jockey Arvind Kumar N was "Guilty" as charged in the matter.

In light of the above, the Stewards decided as under:

- To withdraw the Jockey's Licence granted to Arvind Kumar N and treat him as a disqualified person with effect from 30-9-2022 to 29-1-2023 (Both days inclusive) for Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing on his mount BELDONA (he is not permitted to ride work).
- He was informed of his right to appeal to the Board of Appeal.

NINTEENTH DAY, SATURDAY, 23rd JULY, 2022

(A)

Race: 120. The Sha Tin Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25, to be ridden by Indian Jockeys Claiming allowance (Whips not allowed).

Trainer Mr. M. Rajendra Singh and Jockey L. Alex Rozario were questioned regarding running and riding of PORT OF BEAUTY in the above race. After due enquiry, their explanations were noted future reference.

(B)

ENTERY INTO THE STABLE AREA (UNAUTHORISED PERSON)

The Stipendiary Stewards reported Mr. Syed Muheeb (Racehorse owner) to the Stewards wherein he had accompanied an unauthorised person "Devendra Singh Goldie" and visited Trainer Mr. M. Rajendra Singh's stables in his absence on 23/7/2022 after the last race on the said day.

The Stewards held an enquiry on 21st September, 2022 & examined owner Mr. Syed Muheeb and Trainer Mr. M. Rajendra Singh.

The Stewards considered the following:

- 1. Charge sheet issued to Owner Mr. Syed Muheeb by the Stipendiary Stewards;
- 2. The Submissions made by Mr. Syed Muheeb and Trainer Mr. M. Rajendra Singh during the preliminary enquiry;
- 3. The Stewards noted that Owner Mr. Syed Muheeb had pleaded guilty before the Stewards as charged in the matter;
- 4. The Stewards also noted the unconditional apology tendered by Owner Mr. Syed Muheeb during the course of enquiry with specific reference in accompanying unauthorised person "Devendra Singh Goldie" in the stable area without the prior permission of the office of the Bangalore Turf Club and in absence of Trainer Mr. M. Rajendra Singh.

The Stewards, after detailed deliberations decided to:

- (a) suspend the ownership approval for owning race horses by Mr. Syed Muheeb and him from **30-9-2022 and 29-10-2022 (Both days inclusive)**;
- (b) Fine him a sum of Rs. 50,000/- for Contravention of Rule No. 202 (i) (c) (improper practice) & (d) (Dishonourable action) of the B.T.C Rules of Racing with respect to accompanying unauthorised person "Devendra Singh Goldie" in the stable area without the prior permission of the office of the Bangalore Turf Club and in absence of Trainer Mr. M. Rajendra Singh.
- (c) He was informed of his right to appeal to the Board of Appeal.

FOURTH EXTRA DAY, FRIDAY, 19th August, 2022

(A)

Race: 189. The World Photography Day Cup - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over.

The Stipendiary Stewards reported Trainer Mr. Dheeraj V to the Stewards for Contravening Rule Nos. 159 (a) & (b), 167 (b) & 202 (vi) of the B.T.C. Rules of Racing in respect of his charge KINGS SPEECH and Jockey S. Hussain to the Stewards for contravention of Rule No. 159 (a) & (b) of the B.T.C Rules of Racing on his mount KINGS SPEECH.

The Stewards held an enquiry on 21st September, 2022 and examined Jockey S. Hussain and Trainer Mr. Dheeraj V.

The Stewards considered the following:

- (a) Charge sheet issued to Trainer Mr. Dheeraj. V and Jockey S. Hussain by the Stipendiary Stewards;
- (b) The submissions made by Jockey S. Hussain, Mr. Kiran H. Lakhani spokesman for Trainer Mr. Dheeraj V. and Trainer Mr. Dheeraj. V himself during the enquiry;
- (c) The Stewards viewed the various angles of the race with specific reference to the riding of Jockey S. Hussain in the above race;
- (d) The Stewards noted that Jockey S. Hussain had not pleaded guilty of alleged breach of Contravening Rule No. 159 (a) & (b) of the B.T.C Rule of Racing as charged by the Stipendiary Stewards.
- (e) The Stewards also noted that Trainer Mr. Dheeraj. V had not pleaded guilty of alleged breach for Contravening Rule Nos. 159 (a) & (b), 167 (b) & 202 (vi) under BTC Rules of Racing as charged by the Stipendiary Stewards;

Thereafter, the Stewards after detailed deliberations and acting on their observations arrived at a unanimous decision that Jockey S. Hussain and Trainer Mr. Dheeraj. V were "Guilty" as charged in the matter by the Stipendiary Stewards.

In light of the above, the Stewards decided as under:

- (a) To withdraw the trainer's licence granted to Mr. Dheeraj. V and treat him as a disqualified person with effect from **30-9-2022** to **30-3-2023** (**Both days inclusive**) for Contravening Rule Nos. 159 (a) & (b), 167 (b) & 202 (vi) of the BTC Rules of Racing in respect of his charge KINGS SPEECH.
- (b) To withdraw the Jockey's Licence granted to S. Hussain and treat him as a disqualified person with effect from **30-9-2022 to 31-8-2023 (Both days inclusive)** for contravening Rule No. 159 (a) & (b) of the B.T.C Rules of Racing for not permitting his mount KINGS SPEECH to run on its merits (He is not permitted to ride work).
- (c) They were informed of their right to appeal to the Board of Appeal.

BANGALORE WINTER MEETING 2021-22 FIFTEENTH DAY, THURSDAY, 30TH DECEMBER, 2021

Race: 112. The Chambal Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over, to be ridden by Indian Jockeys claiming allowance (Whips not allowed).

Based on the written complaint dated 30th December, 2021 lodged by Dr. R. Senthil Kumar (Chief Veterinary Officer), the Stipendiary Stewards reported Trainer Mr. S. Padmanabhan to the Stewards for Contravention of Rule No. 202 (xii) of the B.T.C Rules of Racing with specific reference to misconduct by Trainer Mr. S. Padmanabhan towards Dr. R. Senthil Kumar (Chief Veterinary Officer) with regards to the withdrawal of his charge JAN ZIZKA in the above race.

The Stewards held an enquiry on 24th September, 2022 and examined Trainer Mr. S. Padmanabhan.

The Stewards, after deliberations unanimously decided that Trainer Mr. S. Padmanbhan was "**Guilty**" as charged in the matter.

In light of the above, the Stewards decided as under:

- (a) To fine Trainer Mr. S. Padmanabhan a sum of Rs.25,000/- for Contravention of Rule No. 202 (xii) of the B.T.C Rules of Racing with specific reference to misconduct towards Dr. R. Senthil Kumar (Chief Veterinary Officer) - with regards to the withdrawal of his charge JAN ZIZKA in the above race;
- (b) He was informed of his right to appeal to the Board of Appeal.
