

## GENERAL RULES OF NATIONAL TOTALIZATOR RULES

- The unit receipt on all pools is Rs.10/-
- The sale of wagering receipts on the On-Course and Off-Course wagering days starts at 10:00 am and the Wagering counters will be open until the last race of the day.
- Wagering Counters at 1st & 2nd enclosures will be in operation, 30 minutes before the first race of the day and will close 30 minutes after the last race of the day.
- Please check your receipts for the requested Race No, Pool Name, and horse numbers before leaving the counter, as no complaints will be entertained in the future, regardless of the circumstances.
- Patrons must ensure they receive the exact amount of dividends and denominations before leaving the counter.
- Cashable receipts (winning/refund) are valid only for 9 days from the date of issuance and Non-race day payments for valid Receipts will be made every Monday at gate no. 3 between 10.30 AM to 12.30 PM.
- Discoloured, disfigured, taped, and lost receipts will not be paid under any circumstances.
- The payment of dividends exceeding Rs.10,000/- shall be subjected to a TDS deduction at the rate of 30% and such payments are done only by cheque from the payee A/c.
- Refunds of investment will be made on horses that are withdrawn or declared as Nonstarter.
- The minimum number of runners declared to begin the operations of the individual pools is as follows

#### LAUNCH OF THE COMBINED NATIONAL TOTALIZATOR SYSTEM

#### NATIONAL TOTE / COMMINGLING:

National Tote / Commingling of pools, is the process where one Club combines its wagering pool with other race clubs to create **one common dividend**.

Customers wagering into a commingled pools can wager with more confidence as bigger pools will **potentially lead to better dividends**.

#### **Importance of National Tote:**

Previously, wagering on tote was operated by the individual clubs on their races with dividend pool limited to the centre. The dividend depended on the pool amount that the individual club collected and consequently the dividends were not the same at different centers. It is for this reason many horse racing aficionados had been advocating a National Tote which would not only be beneficial to the Race Clubs but also to the Racing lovers.

#### **Key Advantages of National Tote:**

- Common rules and standards across the industry
- Increased stability of the pools
- Larger pool size that gives more confidence to the patrons
- Bring professional punters to the Tote System
- Potential better dividends
- Better racing experience
- Improved transparency and accountability of operations

## **POOLS COMBINED FOR NATIONAL TOTE**

### **SINGLE RACE POOLS**

**WIN: Minimum receipt Rs. 10/- (inclusive of GST)** When you bet a horse to WIN, you get dividend only if your horse finishes first.

**PLACE: Minimum receipt Rs. 10/- (inclusive of GST)** Pick a horse to finish 1st, 2nd or 3rd (in races with 7 or more runners). With 6 or fewer runners, your choice must finish 1st or 2nd.

**Second Horse Pool Minimum receipt Rs. 10/- (inclusive of GST)** Pick a horse to come 2nd only.

**Third Horse Pool Minimum receipt Rs. 10/- (inclusive of GST)** Pick a horse to come 3rd only.

**Show Horse Pool Minimum receipt Rs. 10/- (inclusive of GST)** Pick a horse to finish 1<sup>st</sup> or 2<sup>nd</sup> position in a Races.

**Forecast Pool Minimum receipt Rs. 10/- (inclusive of GST)** Pick two horses to finish 1<sup>st</sup> and 2<sup>nd</sup> in correct order.

**Quinella Pool Minimum receipt Rs. 10/- (inclusive of GST)** Just like the Forecast Pool except you win if your choices finish 1st and 2nd or 2nd and 1st. In other words, so long both your chosen horses figure in the first two, the order of finish does not matter.

**Tanala Pool Minimum receipt Rs. 10/- (inclusive of GST)** Pick 3 horses to finish 1st, 2nd or 3rd in the exact order or buy a combination receipt where your first three choices finish in the exact 1-2-3 order to earn the 100% dividend.

**Exacta Pool Minimum receipt Rs. 10/- (inclusive of GST)** Pick four horses to finish 1<sup>st</sup> - 2<sup>nd</sup> -3<sup>rd</sup> - 4<sup>th</sup> in correct order.

### **MULITLEG RACE POOLS**

**Jackpot Minimum receipt Rs. 10/- (inclusive of GST)** Select the winners of the five races designated by the Club for the Jackpot Pool at the declaration stage. You can either buy a single-digit receipt (e.g., 1-8-5-2-12) or a combination receipt (e.g., 1/6-7/8-5-2-6/12). If you get the first four winners correct, you share in the consolation dividend of 30%. If you get all 5 legs right, you share in the 70% dividend amount.

**Mini Jackpot Minimum receipt Rs. 10/- (inclusive of GST)** Select the winners of the four races designated by the Club for the Mini Jackpot Pool at the declaration stage. You can either buy a single-digit receipt (e.g., 1-8-5-2) or a combination receipt (e.g., 1/6-7/8-5-2-6/12). If you get the first four winners correctly, you share in the 100% dividend amount.

**Treble Pool Minimum receipt Rs. 10/- (inclusive of GST)** Select the winners of the three races designated by the Club for the Treble Pool at the declaration stage. You can either buy a single-digit receipt (e.g., 1-8-5) or a combination receipt (e.g., 1/6-7/8-5-2-6). If you get the first three winners correctly, you share in the 100% dividend amount.
