- (iii) To forfeit Rs.11,800/- (Inclusive GST) paid by Trainer Mr. Warren Singh towards the Appeal fee.

- (iii) To forfeit Rs.11,800/- (Inclusive GST) paid by Jockey K. Sai Kiran towards the Appeal fee.
