## **ORDER OF THE BOARD OF APPEAL**

### **BANGALORE SUMMER MEETING 2025** **THIRTEENTH DAY, SATURDAY, 28<sup>TH</sup> JUNE 2025**

#### **Race: 89. The Malakpet Plate - Div. II - (About) 1300 metres. Horses rated 20 to 45.**

The Board of Appeal of Bangalore Turf Club Ltd., at its meeting held on 25<sup>th</sup> August, 2025 considered the appeal dated 20<sup>th</sup> July, 2025 filed by Trainer Mr. G.Y. Rajesh Babu against the decisions of the Stewards at their meeting held on 18<sup>th</sup> July, 2025 [who was declared as a "disqualified person" w.e.f 28/07/2025 to 28/06/2026 [Both days inclusive] for Contravention of Rule No. 202 of the BTC Rules of Racing in respect of his charge ADELANTO.

The Board also noted that pending and final disposal of the appeal, the board had stayed the punishment.

#### **After consideration of all of the above, the Board unanimously decided as follows:-**

- 1) To partially allow his appeal;
- 2) Consequently, the revised order of the punishment imposed on Trainer Mr. G.Y. Rajesh Babu is to suspend the trainers licence granted to him with effect from **29<sup>th</sup> August, 2025 to 28<sup>th</sup> February, 2026 [Both days inclusive]** i.e., for a period of six months for Contravention of Rule No. 202 under the B.T.C Rules of Racing pertaining to the difference in weight in respect of his charge ADELANTO;
- 3) To forfeit the appeal fees of Rs.11,800/- (inclusive GST) from Trainer Mr. G.Y. Rajesh Babu towards the appeal fee.

The Board of Appeal of Bangalore Turf Club Ltd., at its meeting held on 25<sup>th</sup> August, 2025 considered the appeal dated 29<sup>th</sup> July, 2025 filed by Trainer Mr. Warren Singh against the decisions of the Stewards at their meeting held on 28<sup>th</sup> July, 2025 [who was declared as a "disqualified person" w.e.f 06/08/2025 to 05/08/2026 [Both days inclusive] for Contravention of Rule No. 159 (a) & (b) of the BTC Rules of Racing in respect of his charge THE GOLDEN DREAM.

- 2) Consequently, the revised order of the punishment imposed on Trainer Mr. Warren Singh is to suspend the trainers licence granted to him with effect from **29<sup>th</sup> August, 2025 to 28<sup>th</sup> February, 2026 [Both days inclusive]** i.e., a period of six months under the B.T.C Rules of Racing in respect of his charge THE GOLDEN DREAM;
- 3) To forfeit the appeal fees of Rs.11,800/- (inclusive GST) from Trainer Mr. Warren Singh towards the appeal fee.

#### **After consideration of all of the above, the Board unanimously decided as follows:-**

- 1) To partially allow his appeal & modify the charges to Contravention of Rule No. 202 (vi) of the BTC Rules of Racing for tendering false and misleading evidence during the enquiry;
- 2) Consequently, the revised order of the punishment imposed on Jockey A.R. Pradeep is to suspend the Jockeys licence granted to him **for the first eight (8) race days of Bangalore Winter Meeting 2025-26** in respect of his mount THE GOLDEN DREAM (**HE IS PERMITTED TO RIDE WORK**);
- 3) To forfeit the appeal fees of Rs.11,800/- (inclusive GST) from Jockey A.R. Pradeep towards the appeal fee.
